Sharon Keller was first elected to the Texas Court of Criminal Appeals in 1994. She was elected Presiding Judge in 2000 and re-elected to that position in 2006. She is the first woman to have served on the Court. A native Texan, she earned her Bachelor of Arts degree in philosophy from Rice University in 1975 and her Juris Doctor degree from Southern Methodist University School of Law in 1978.

Presiding Judge Keller is chairman of the Texas Indigent Defense Commission, and she is on the board of the Council of State Governments Justice Center. She is a Life Fellow of the Texas Bar Foundation and a member of the Judicial Advisory Council to the Community Justice Assistance Division of the Texas Department of Criminal Justice. By virtue of her office, she is vice-chair of the Texas Judicial Council. Her current term extends through December of 2024. In 2003 Presiding Judge Keller received the Distinguished Alumni Award for Judicial Service from the SMU Dedman School of Law.



Dr. Phil McGraw

Founder of groundbreaking jury sciences firm, Courtroom Sciences, Inc. "CSI"; host of the syndicated television program "Dr. Phil"

In 1990 after obtaining his Masters Degree and Doctorate from the University of North Texas in clinical psychology, Phillip McGraw co-founded a ground breaking trial science firm, Courtroom Sciences, Inc. (the original "CSI"). Located in Las Colinas, CSI's facilities feature replicas of both state and federal courtrooms. One of his first cases involved a claim that the Journal of the American Medical Society had defamed an author of a book about the Kennedy assassination. The author claimed that the wound in President Kennedy's neck was an entry, not exit, wound, and further that as a resident at Parkland Hospital he had been present in the trauma room and personally observed the wound. But the journal debunked the claim. McGraw helped prepare the JAMA witnesses for deposition and organized a mock trial. The case ultimately settled. Over the years CSI represented many Fortune 500 companies and McGraw worked alongside some of the top litigators in the world. CSI, based on sound scientific principles developed by McGraw, was one of the early trial consulting firms in what now has become an industry. In 1998 McGraw was asked to assist in a trial where Oprah Winfrey and her production company had been sued in Amarillo by several cattle feeders over a broadcast on mad cow disease. After Oprah and her company won the case McGraw began appearing on the Oprah Winfrey Show which led to his own program Dr. Phil. Hi work at CSI later inspired the CBS program "Bull" about a New York jury consulting firm. McGraw was the executive producer of the series and one of its script writers.

He is now one of the most well-known and trusted mental health professionals in the world, and hosts daytime TV's top-rated program, *Dr. Phil.* Now in its 21st season, this trailblazing and award-winning platform continues to provide the most comprehensive forum on mental health issues in the history of television. Dr. McGraw's unique ability to take complicated and technical information and make it accessible and understandable to the general public has distinguished him both among viewers and within his profession.
